Thank you for your letter dated December 20, 2022, regarding proposed Rule Chapter 60H-6, F.A.C. Please see the responses below.

60H-6.004: This issue has been addressed in the Notice of Change, which will

publish on January 13, 2023 ("NOC").

60H-6.005: "Pool" is defined in section 255.502(11), F.S., as "the Florida Facilities

Pool created in s. 255.505." "Buildings in the Florida Facilities Pool" is defined in proposed rule 60H-6.004(2), F.A.C., as published in the NOC, as "buildings in the pool established by the Department pursuant to section 255.505, Florida Statutes, all portions of the Capitol Complex

Space, and any associated state-owned lands."

60H-6.005(1): "Buildings in the Florida Facilities Pool" was defined in proposed rule

60H-6.004(2), F.A.C., as published in the Notice of Proposed Rule, and is still defined in proposed rule 60H-6.004(2), F.A.C., as published in the

NOC.

Rule 60H-6.005, F.A.C., currently provides the authority to close buildings as the result of a valid emergency. However, additional clarity has been provided. Please see the revised language as published in the

NOC.

As defined, the term "Buildings in the Florida Facilities Pool" includes the land associated with the buildings. However, there is a distinction between indoor and outdoor spaces. Additional restrictions apply to indoor spaces. Please see the revised language as published in the NOC. 60H-6.008(1): Please see the revised language as published in the NOC.

60H-6.005(2): Please see the revised language as published in the NOC.

60H-6.005(4): Please see the revised language as published in the NOC.

60H-6.005(6): Proposed Rule 60H-6.011(2)(e), F.A.C., as published in the NOC

describes solicitations as "offering items or services for sale, or soliciting

fares, alms, or contributions" unless authorized by law.

The definition of "Buildings in the Florida Facilities Pool" as published in

the NOC includes any associated state-owned lands.

60H-6.008(4): The jurisdiction of Capitol Police is independent of DMS's rules. A link to

information regarding Capitol Police's requirements is provided in the

Use of Capitol Complex Guidelines, Page 5, IV. C.

60H-6.0085: Lighting of the Capitol is government speech and as such is

appropriately directed at the discretion of the Governor. Please see the

revised language as published in the NOC.

60H-6.011(2): Please see the revised language as published in the NOC.
